PUBLIC CONCERNS

The Board was questioned on the status of the contract to provide fire protection for the Town. The Town Supervisor advised that the eventual contract was a work in progress and all avenues are being explored, including contracting with adjacent Towns. The contract will be for the Unadilla Forks Fire Protection District and will not affect any established Fire Districts in the Town at this time. The Town Supervisor also advised that the goal of the entire Board was to provide quality fire protection for the residents. A public hearing is required and will be scheduled to discuss and sign any contract.

HIGHWAY REPORT

Highway Superintendent advises the new 10 wheel plow truck is off the assembly line, but he is unsure if it has been shipped. One of the Highway employees has been injured and is recovering. Coverage for inclement weather is in place.

ASSESSOR REPORT

The Assessor is collecting and verifying data. The Sr.STAR and Agricultural exemption renewals are received from the County at the end of the month. They will need to be returned by March 1st.
