ASSESSOR REPORT-Town Assessor John Davidson reports he is collecting data to update any mis-measured property in the Town, and advises the 2016 tax roll is close to being finalized. John also reports one or preferably two members are needed for the Board of Assessment Review.

HIGHWAY REPORT-Highway Superintendent, Rod Jennison reports that his crew continues ditching roadsides, patching and cutting shoulders in preparation of road re-surfacing. Rod wishes to thank the surrounding Towns for their help in trucking stone and other material. The loader is in Syracuse to repair the center pin. Estimate of cost to repair is \$2800.00. NYS DEC has inspected the salt/sand pile and has required the Town construct a salt storage facility. A grant is available to cover a large percentage of the cost if not all. Dan Wilber advises the County may give assistance in completing the grant application. Supervisor Todd Lewis will contact a professional firm as well.

SUPERVISOR REPORT-There was no Supervisor report as all required bank statements were not received.

NEW BUSINESS-Supervisor Lewis read a letter from the committee that sponsored the Memorial Day celebration. A copy is recorded with the Town Clerk.

The Board approved a request from the Highway Superintendent Jennison to elevate the part-time employee to an hourly rate of \$15.50. The full time employees receive \$17.00 and the Deputy Superintendent receives \$17.50 per hour.
