ASSESSOR REPORT

John Davidson advises he is working on same issues as last month.(Aerial photos,accurate property info)

HIGHWAY REPORT

Rod Jennison advises he and his crew are cleaning all equipment and facilities. The crew is also cutting shoulders on Crumb Hill and Talbot roads. #4 truck is back in service and #6 is in for NYS inspection and to check for air leaks. Tri-County radio has sent a quote for installation of 5 mobile radios and 1 base station with antenna. A total of \$6566.00 was quoted as well as an \$1800.00 yearly fee for the radio repeater. No Board action taken at this time as Jon Cockett, Town Clerk, will check to see if radio communication can be installed in house. If so, he is authorized to spend up to \$1000.00 on a motion by Jim Roberts and seconded by Mike Laukaitis. The Board voted with Lewis-aye, Roberts-aye, Laukaitis-aye, Rogers-aye, Peeters-aye. Carried The front rims on loader are bad. It will cost \$1350.00 per rim plus installation.Rod will begin process of installation. The F-550 is at Skinners in Richfield Spa to find a battery draw as something is causing the battery to drain,not allowing vehicle to start.

Rod advises there is equipment that has not been used for a long period as well as equipment that should be replaced and upgraded. The following vehicles are recommended for dispersal by Auctions International. 1) 4-wheel drive Oshkosh, 2) 1991 International Dump, 3)2011 Ford F-550. Discussion centered on a reserve price placed on all vehicles as follows. #1-\$10,000.00, #2-\$19,500.00, #3-\$28,500.00. A motion by Connie Peeters to have Auctions International sell any and all 3 vehicles, provided the reserve was met, was seconded by Mike Laukaitis. This will expedite any permits or other paperwork required by DEC or NYS DOT. Ken has advised the State does not want a concrete abutment on Creekside away from road, they prefer rip-rap. Todd has met with Tracy Hula, Gates-Cole Insurance. The current coverage the Town has will stay the same. Some values have been reduced but will only save the Town around \$500.00. Further evaluation needs to be done.
