Deputy Supervisor Jim Roberts opened the meeting at 700pm with the Pledge of Allegiance.

Deputy Supervisor welcomed comments or concerns from the Public, but first it was communicated that Todd Lewis was recovering from hand surgery. The Board and the Public wished Todd a speedy recovery.

Public concern centered on the dangerous tree on the border of Town property and property owned by David Trevett. James Roberts advised he has not had any luck contacting Trevett, and will do so and report back.

# **ASSESSOR REPORT**

### **HIGHWAY REPORT**

Kendrick advises Gas City Rd is complete.

South Road ditching will start Monday, "call before you dig" have been contacted to mark any underground utilities. The road will be closed while ditching is in progress. Jim Roberts questioned how the bad spots on South Rd will be addressed, it was the consensus of the Board not to just fill in with patch, the areas should be dug up and a proper base installed.

Ken Roberts was unable to attend tonight's meeting, due to emergency, he has although submitted all necessary forms to NYSDEC so work may progress on Saunders Gulf Road.

Jim Roberts questioned why ditching on Fiddlers Green Rd was still being done in a manner which accelerates erosion due to the depth as well as no shoulder, as the ditching begins where the pavement ends, this practice has caused trees to fall down on previous ditching and is a safety hazard.

An amendment to the 284 agreement dated 6/22/15 was discussed. An additional \$5000.00 was authorized to permit the contractor ditching on South Rd. to provide all equipment and manpower, thereby freeing up Town employees and equipment for other tasks

.A question of the status of 2-way radio communications was presented. Kendrick was unsure if the radios worked. It was advised by the Board to make this a priority as employee safety is at stake.

Kendrick advises he is scheduled for knee surgery on Aug. 17. The procedure is being handled as an outpatient. Connie Peeters questioned if the change of employee status form was submitted to Otsego County personnel as required by the retirement of highway employee. Kendrick advises he has talked to the County and no form is required.

Kendrick will call Williams tire to see if loader tire is warranted for the cut received.
