Supervisor Lewis advised Kendrick that he met with Ken Roberts,P.E. on a solution for DOT yellow flag on Saunders Gulf Rd. Roberts thinks the job could be done for 10 to \$15,000,not \$60,000 as a prior estimate received by Kendrick. Kendrick was given a phone number to call Ken and set up a time when the two of them can meet and discuss repairs that will satisfy NYS DOT.Kendrick will report at December meeting.
