Supervisor Lewis opened the meeting at &00pm with the Pledge of Allegiance

HIGHWAY REPORT

Rod Jennison advises his crew has started ditching in preparation for upcoming road projects. Rod is working on a \$30,000.00 grant to apply towards possible purchase of new plow truck. A letter was read from Town resident Daniel Yoder that requests attention be paid to bridge over Mill Creek Rd. The bridge is rated 3 ton and has progressed to the point of being unsafe for school buses and similar vehicles. Rod will keep track of situation. Two part time employees are requested by Rod to work a maximum of 3 ten hour days beginning in May and lasting till around August this year. Discussion centered on following Union contract policies and giving Harold Grosvent first chance at one of the positions. Connie Peeters motioned to let Rod hire the 2 part timers, with the understanding Harold will have first chance at one position and all Union rules are followed. Second by Jim Roberts. The Board voted with Lewis-aye, Roberts-aye, Rogers-aye, Peeters-aye, Jennison-aye. Carried.

Rod requests Linn White, provisional Highway employee, be given full time status as Town Highway HMEO. Connie Peeters motioned to appoint Linn to the full time position. Second by Wendell Rogers. The Board voted with Lewis-aye, Roberts-aye, Rogers-aye, Peeters-aye, Jennison-aye. Carried. Truck #4 is in need of dump box repairs. An estimate from Whites welding for \$1151.20 was received for the repair. Jim Roberts motioned to authorize the expenditure for the repair. Wayne Jennison seconded. The Board voted with Lewis-aye, Roberts-aye, Rogers-aye, Peeters-aye, Jennison-aye. Carried.
